The River Road Neighborhood Association was founded as a 501 (c) 3 in 1977.

The River Road Historic District was designated in February of 2010 by the City of San Antonio to preserve and protect the River Road Neighborhood's important historic resources. (see map)

History of RRNA Historic Design Guidelines Initiative

2010	Initial effort to develop historic design guidelines
2014	Renewed effort due to concern about increased development pressures
2019	RRNA approves moving forward with Historic Guidelines Initiative
2020	Request for Proposals (RFP) was generated by RRNA
2021	Project Initiated

The first effort to develop specific River Road Historic District Guidelines was started in 2010.

In 2014, a second effort was made by neighbors concerned that district specific guidelines were important due to increased development pressures.

In 2019, after many, many hours of deliberations at Historic Design & Review Commission meetings regarding cases that neighbors' felt could have been resolved more clearly if we had River Road Historic District guidelines in place, a new third effort was launched!

In early 2020, a Request for Proposals (RFP) was generated by RRNA's Planning Team and sent to design firms specializing in the development of historic district guidelines.

The RRNA Board of Directors selected HHM & Associates based in Austin.

Suggestions regarding firms to receive the RFP were solicited from current and former Historic Design & Review Commissioners, the City's Office of Historic Preservation leadership, The Conservation Society of San Antonio leadership, and River Road neighbors. Eighteen firms from San Antonio, Austin, Denton, Denver, Nashville, Chicago, and Philadelphia were sent an RFP. Firms from San Antonio, Austin, Denton and Chicago responded.

Proposals were received and evaluated and a final selection was presented to the RRNA Board for approval in 2020. The firm selected by the RRNA Board of Directors is HHM & Associates, Austin
